

DECISION No 7/2019

**OF THE ADMINISTRATIVE BOARD OF THE AGENCY FOR THE
COOPERATION OF ENERGY REGULATORS**

of 13 June 2019

**on the appointment of one Member of the Administrative Board as reporting officers for
the assessment of the annual performance of Mr Alberto POTOTSCHNIG for the
reference period 1 January 2018 to 31 December 2018**

THE ADMINISTRATIVE BOARD OF THE AGENCY FOR THE COOPERATION OF
ENERGY REGULATORS,

Having regard to the Staff Regulations of Officials of the European Communities (Staff Regulations) and the Conditions of Employment of Other Servants of the European Communities (CEOS), laid down by Council Regulation (EEC, EURATOM, ECSC) No 259/68¹, and, in particular, Article 43 of the Staff Regulations and Article 15(2) of CEOS,

Having regard to Decision No 26/2011 of the Administrative Board of the Agency for the Cooperation of Energy Regulators of 22 September 2011 concerning the appraisal of the Director of the Agency for the Cooperation of Energy Regulators, and, in particular, Article 3 thereof,

Whereas:

- (1) The ability, efficiency and conduct in the service of each member of the staff of the Agency shall be the subject of an annual appraisal report.
- (2) For this purpose, the Administrative Board shall appoint two reporting officers to assess the annual performance of Mr Alberto POTOTSCHNIG, selecting one of them among the members of the Administrative Board appointed by the European Commission,
- (3) Mr Alberto POTOTSCHNIG acted as Director of the Agency for the Cooperation of Energy Regulators until 15 September 2018. As of 16 September 2018, he was assigned the function of Director *ad interim*;
- (4) With Decision No 2/2019, the Administrative Board appointed Ms Agnieszka KAZMIERCZAK and Mr Jochen PENKER as reporting officers for the annual appraisal of

Mr Alberto POTOTSCHNIG for the reference period of 1 January 2018 to 31 December 2018,

- (5) Ms Agnieszka KAZMIERCZAK is no longer a Member of the Administrative Board of the Agency and therefore she shall be replaced by another Member in her function of reporting officer,

HAS ADOPTED THIS DECISION:

Article 1

Ms Anne MONTAGNON is appointed as reporting officer for the annual appraisal of Mr Alberto POTOTSCHNIG for the reference period of 1 January 2018 to 31 December 2018.

Ms Anne MONTAGNON replaces Ms Agnieszka KAZMIERCZAK.

Article 2

This Decision shall enter into force on the day of its adoption.
