#### 1. Opening

The meeting was opened by the chair who welcomed the Experts. The minutes of the last meeting were approved without any changes. The draft agenda was approved as mirrored below.

#### 2. Recent issues

The chair provided an update on recent developments with regard to REMIT since the last Expert Group meeting.

The Agency updated Experts about the content of the RRM User Group Infosheet No 19 published in February regarding New Aris Digital Certificates, RRM admin account compliance and the New Guidance on UTI. The Experts informed that it was not possible from their side to delete RRM admins whose Certificates expired.

The Agency updated Experts on the recast regulation on ACER.

The Agency updated Experts on the revision of the annual programming document for REMIT based on the latest allocation of the budget for the Agency. This included the decision on resignation from direct communication with the stakeholders (via REMIT mail) and limiting the roundtable meetings.

The implementation of Schema will happen this year but for REMIT Stakeholders the implementation will not take place before 2020. Update will be provided in the Spring.

#### 3. Update on the market abuse guidance

Representatives of the Agency's Market Surveillance and Conduct Department presented potential topics for the guidance on the market abuse. The document will undergo further consultations prior to its publication.

The MSC prepared and presented the feedback on the received comments from Experts.

The communication was shared on the next steps: end of March is the target for the publication.

The Experts provided their feedback on the draft guidance document.

## 4. Disclosure of inside information and transparency - Survey on implementing thresholds for the publication of II

Representatives of the Agency's Market Integrity and Transparency Department presented the table with the contributions from Experts (Table). The particular questions were discussed with Experts and their feedback was noted.

ACER agreed to present more background to what questions would be needed. Another session would be held and be dedicated to this topic. To consultation to be published before summer and presented at the EMIT forum. Experts kindly invited to the EMIT forum for further discussions.

#### 5. Amendments to Chapter 7 of the ACER Guidance

The Agency presented on the envisaged changes and further steps.

Experts extensivelly discussed the proposed amendments and provided their input.

#### 6. ACER Open letter on Brexit: State of play and the challenges for REMIT
