

DIRECTOR DECISION 2022-15

of 20 September 2022

**establishing the Public Holidays for the year 2023
at the European Union Agency for the Cooperation of Energy Regulators**

THE DIRECTOR OF THE EUROPEAN UNION AGENCY FOR THE COOPERATION OF ENERGY REGULATORS,

Having regard to Regulation (EU) No 2019/942 of the European Parliament and of the Council of 5 June 2019 establishing a European Union Agency for the Cooperation of Energy Regulators¹ (hereafter referred to as the “Agency”), and, in particular Article 24 thereof,

Having regard to the Staff Regulations of officials and the Conditions of Employment of other servants of the European Communities (hereinafter “CEOS”), laid down by Council Regulation (EEC, EURATOM, ECSC) No 259/68², and, in particular Article 61 of the Staff Regulations and Articles 16 and 91 of the CEOS,

Having regard to Commission Decision C(2020) 1559 amending Decision C(2013) 9051 of 16 December 2013 on leave, and in particular III.f and III.g thereof,

After consulting the Staff Committee on 20 September 2022,

Whereas:

- (1) Every year the Agency issues a list of public holidays for the following calendar year.
- (2) Following Commission Decision C(2020) 1559 amending Decision C(2013) 9051 of 16 December 2013 on leave, the total number of public holidays shall be between 17 days (minimum) and 19 days (maximum),

HAS ADOPTED THIS DECISION:

Article 1

The following 19 days will be considered as public holidays for the Agency in 2023, provided that the needs of the service would not require otherwise:

Article 2

Without prejudice to the schedule of holidays for 2023, Monday, 1 January 2024 and Tuesday, 2 January 2024 will be holidays.


Article 3

Staff may choose to work on the following 3 days: Maundy Thursday (06.04.2023), Good Friday (07.04.2023) and the day following Ascension Day (19.05.2023), which are considered as public holidays. The number of days worked will be added to the annual leave balance of the current year (2023). Staff working during public holidays must get prior approval from the immediate supervisor by submitting a request through Sysper or via e-mail (for trainees and interim staff). Teleworking days are to be treated as normal working days conferring entitlement to this flexibility.

Article 4

This Decision shall enter into force on the day of its adoption and shall be communicated to all staff.
