1. **MEETING OPENING PART**

The first meeting of the new Expert Group on the Power Purchase Agreements ('the Group') in a virtual format was opened and the agenda was approved.

The chair welcomed the Group's members and outlined the purpose of the Group.

ACER introduced the Terms of Reference and Rules of Procedure, outlining the schedule and operational procedures for future sessions. The discussions commenced with an introduction of ACER's new tasks under the EMD reform, focusing on the purpose and expectations of the expert group.

During the tour de table, experts briefly presented themselves, followed by an expression of their stance on the introduction of voluntary templates for Power Purchase Agreements (PPAs). Views were shared both in favour and against.

Experts covered several of the prevailing barriers and risks within the PPA market.

Subsequently, polls were conducted to gather relevant inputs from the expert group.

DISCUSSION ON THE EXISTING TEMPLATES FOR POWER PURCHASE 2. **AGREEMENTS**

The meeting proceeded with a focused discussion on the existing templates for Power Purchase Agreements (PPAs), aiming to gather insights from experts regarding their experiences with these templates and to identify their effectiveness and drawbacks.

Experts shared their experiences regarding the utilisation of existing templates for concluding PPAs, providing valuable insights into their practical application.



The discussion delved into addressing questions such as: What is missing in existing templates, and can these gaps be overcome? What unique aspects could a new ACER template bring that are not currently addressed by others?

Through active engagement, experts exchanged views, identified key challenges, and proposed potential solutions to enhance the effectiveness of PPAs.

3. THE MEANING OF 'VOLUNTARY TEMPLATES FOR PPAS'

The third part of the meeting consisted of a comprehensive discussion aimed at clarifying the concept of 'Voluntary Templates for Power Purchase Agreements (PPAs).' Experts deliberated on the scope of the proposed templates, identifying the main potential target users and determining which aspects should be included or excluded.

During the brainstorming session, participants engaged in a proactive discussion to outline the essential features that a potential template should possess and on some of the potential missing features of existing templates (e.g. EFET, ISDA, national templates, in-house, etc.).

Certain experts suggested preparing a set of 'PPA best practices' by ACER as an alternative to the voluntary template(s).
