1. **MEETING OPENING PART**

The third meeting of the Expert Group on the Power Purchase Agreements ('the Group') in a virtual format was opened and the agenda was approved. The minutes from the previous meeting were also reviewed and approved.

The chair highlighted the primary objectives of the meeting.

2. ALIGNMENT OF TEMPLATE FIELDS WITH REMIT **REPORTING** REQUIREMENTS AND DATA COLLECTING PURPOSES.

Experts' inputs on aligning the template fields with REMIT reporting requirements were reviewed. Key points from various experts were discussed, focusing on enhancing the accuracy and comprehensiveness of data collection.

A Q&A session followed, where participants asked questions and shared insights regarding the alignment process.

3. DISCUSSION ON THE QUESTIONS FOR THE UPCOMING PUBLIC CONSULTATION

The meeting proceeded with a focused discussion on the draft questions prepared for the upcoming public consultation scheduled to be held from June 20, 2024, to July 18, 2024. The experts provided their input and suggestions for refining the questions to ensure clarity and enhance the effectiveness of the consultation process on the topic of voluntary templates for Power Purchase Agreements (PPAs).

The group worked on finalising the questions, ensuring that all critical aspects were covered. Final adjustments were made based on group feedback.



Participants discussed any remaining issues and clarified points of concern regarding the survey and public consultation process.

4. **CLOSING SESSION**

4.1 **Next Steps & Updates**

The timeline for the public consultation was confirmed, running from 20 June to 18 July 2024.

The preparation of ACER's assessment was outlined, with a focus on September and October 2024 for finalising the assessment.

Topics for the next meeting were identified, including:

- Analysis and statistics to include in ACER's future monitoring of market integration, applied to PPAs.
- Key drivers and barriers in market integration linked to the PPA market, that deserve attention and monitoring.

A final Q&A session was held to address any outstanding questions from participants.
