

DECISION No 16/2021

**OF THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR
THE COOPERATION OF ENERGY REGULATORS**

of 16 December 2021

**on the appointment of two Members of the Administrative Board as reporting officers
for the assessment of the annual performance of the Director for the reference period 1
October 2020 to 31 December 2021**

THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR THE
COOPERATION OF ENERGY REGULATORS,

Having regard to Regulation (EU) 2019/942 of the European Parliament and of the Council of
5 June 2019 establishing a European Union Agency for the Cooperation of Energy
Regulators¹,

Having regard to the Staff Regulations of Officials of the European Union (Staff Regulations)
and the Conditions of Employment of Other Servants of the European Union (CEOS), laid
down by Regulation No 31 (EEC), 11 (EAEC)², and, in particular, Article 34 of the Staff
Regulations and Article 14 of the CEOS,

Having regard to Decision No 26/2011 of the Administrative Board of the Agency for the
Cooperation of Energy Regulators of 22 September 2011 concerning the appraisal of the
Director of the Agency for the Cooperation of Energy Regulators, and, in particular, Article 9
thereof,

Whereas:

- (1) The ability, efficiency and conduct in the service of each member of the staff of the
Agency shall be the subject of an annual appraisal report.
- (2) For this purpose, the Administrative Board shall appoint two reporting officers to assess
the annual performance of ACER Director, selecting one of them among the members
of the Administrative Board appointed by the European Commission.
- (3) ACER Director, upon entry into service on 1 January 2020, has been subject to a
probationary period of nine months, from 1 January 2020 to 30 September 2020, in
accordance with Article 14 of the CEOS.

- (4) ACER Director successfully passed the nine months probationary period, confirmed by a probationary period report in line with Decision No 26/2011 of the Administrative Board of the Agency for the Cooperation of Energy Regulators of 22 September 2011.
- (5) Upon written agreement with ACER Director of 31 August 2021, it was decided to combine the performance appraisal for the remaining three months of the year 2020 (1 October 2020-31 December 2020) with the performance appraisal for the reference period 1 January 2021-31 December 2021.
- (6) The Administrative Board shall appoint, among its members, two reporting officers to assess the performance of the Director over the assessment period. One of the members shall be a representative of the European Commission.
- (7) The Representatives of the European Commission within the Administrative Board of ACER are the Director-General of DG ENER and the Director of DG ENER/MOVE's Shared Resources Directorate,

HAS ADOPTED THIS DECISION:

Article 1

Ms Romana JORDAN and the Director-General of DG ENER are appointed as reporting officers for the performance appraisal of the Director for the reference period from 1 October 2020 to 31 December 2021.

Article 2

This Decision shall enter into force on the day of its adoption.
