

#### **DECISION No 05/2024**

## OF THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR THE COOPERATION OF ENERGY REGULATORS

#### of 19 June 2024

amending Decision No 17/2023 on the adoption of the budget and the establishment plan of the European Union Agency for the Cooperation of Energy Regulators for the financial year 2024

THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR THE COOPERATION OF ENERGY REGULATORS.

Having regard to Regulation (EU) 2019/942 of the European Parliament and of the Council of 5 June 2019 establishing a European Union Agency for the Cooperation of Energy Regulators(recast)<sup>1</sup> and, in particular, Articles 1(1), 17 and 19(f) thereof,

Having regard to Decision of the EEA Joint Committee No 93/2017 of 5 May 2017 amending Annex IV (Energy) of the EEA Agreement 2019/205<sup>2</sup>, and, in particular, Article 1(5) thereof,

Having regard to Decision No 08/2019 of the Administrative Board of the Agency for the Cooperation of Energy Regulators of 21 June 2019 on the adoption of the Financial Regulation of the Agency for the Cooperation of Energy Regulators, and, in particular, Articles 31 and 34 thereof,

Having regard to Decision No 02/2023 of 25 January 2023 on amending Decision No 7/2020 of the Administrative Board of the European Union Agency for the Cooperation of Energy Regulators of 17 June 2020 on the adoption of the Rules of Procedure of the Administrative Board of the European Union Agency for the Cooperation of Energy Regulators and, in particular, Article 9 thereof,

Having regard to Commission Decision (EU) 2020/2152<sup>3</sup> of 17 December 2020 on fees due to the European Union Agency for the Cooperation of Energy Regulators for collecting, handling, processing, and analysing of information reported under Regulation (EU) No 1227/2011 of the European Parliament and of the Council, and, in particular, Articles 5 and 6.

- (1) On 13 December 2023, the Administrative Board adopted the budget of the European Union Agency for the Cooperation of Energy Regulators (hereinafter 'the Agency'), for the financial year 2024.<sup>4</sup>
- (2) In January 2024, the Agency established the amount of fees due by applying the approved fees collection model on the records reported by the Registered Reporting Mechanisms (RRMs) for the financial year 2024. The number of records reported by each RRM during the year 2023 has been used as basis for the fees' calculation. The amount of fees envisaged for the financial year 2024 at the time of the budget adoption was EUR 12,439,431, while the total amount of debit notes issued in January 2024 amounted to EUR 11,619,750. Therefore, the Agency's fee revenue for 2024 needs to be adjusted downward by the difference between the initially planned and established revenue, i.e. EUR 819,681.
- (3) Since the approval of the budget, the Agency processed advanced payments for enrolment from three new RRMs, thus collecting EUR 13,500. Therefore, an upward adjustment of the Agency's fee revenue for this amount is required.
- (4) With the required downward and upward adjustments mentioned in the recitals 2) and 3) above, a net reduction of EUR 806,181 of fees-covered projects is needed. The affected projects will mainly be the ARIS archiving solution for EUR 400,000, IT consultancy services for EUR 100,000 and the REMIT Case Management Tool / Notification Platform related investments in new functionalities and improvements for EUR 200,000, as well as reducing in scope the SMARTS/NMS improvements for the SMARTS/NMS visualisation tools and new alerts to support surveillance for EUR 106,181.
- (5) On 15 of May 2024 three new legislations<sup>5</sup> were approved by the budgetary authorities thus releasing the EUR 1,830,000 reserve that was recorded in the approved budget of the Agency and making them now available for use. The revision of the Electricity Market Design regulation, that took place in 2024, after the approval of the budget, provides for additional human and financial resources that require an upward amendment of the budget with EUR 2,656,000 and 11 establishment plan posts (seven temporary agents whose grades are indicated in the establishment plan of Annex II and four contract agents that are not part of the establishment plan). Out of the incoming amount, EUR 485,000 will be distributed towards Title 1 to cover the salaries related expenditure, while the difference of

EUR 2,171,000 will be distributed towards Title 2 and Title 3 to cover the operational expenditure, mainly (a) the development of the database and tools needed for the collection and analysis of the Power Purchase Agreements' data, (b) investment in tools and models to comply with the EU-level assessment of flexibility needs and (c) the additional investments in information security and support/performance/capacity of Agency's IT systems.

(6) It is therefore appropriate to amend Decision No 17/2023 of 13 December 2023 on the adoption of the budget and the establishment plan of the European Union Agency for the Cooperation of Energy Regulators for the financial year 2024,

#### HAS ADOPTED THIS DECISION:

#### Article 1

Annex I and II to Decision No 17/2023 of the Administrative Board of the European Union Agency for the Cooperation of Energy Regulators of 13 December 2023 on the adoption of the budget and the establishment plan of the European Union Agency for the Cooperation of Energy Regulators for the financial year 2024, is replaced by Annex I and II to this Decision.

#### Article 2

This Decision shall enter into force on the day of its adoption.

This Decision shall be published on the website of the Agency, and it shall be communicated to the European Parliament and the Council, the European Court of Auditors and the European Commission.

#### Article 3

This Decision and Annex I and II shall be published in the Official Journal of the European Union within three months from the date of the current decision.
