

### **DECISION No 02/2024**

# OF THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR THE COOPERATION OF ENERGY REGULATORS

# of 14 May 2024

on the appointment of one Member and one Alternate of the Board of Regulators of the European Union Agency for the Cooperation of Energy Regulators

THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR THE COOPERATION OF ENERGY REGULATORS,

Having regard to Regulation (EU) 2019/942 of the European Parliament and of the Council of 5 June 2019 establishing a European Union Agency for the Cooperation of Energy Regulators<sup>1</sup>, and, in particular, Article 19(1)(b) thereof,

Having regard to Decision of the EEA Joint Committee No 93/2017 of 5 May 2017 amending Annex IV (Energy) to the EEA Agreement [2019/205]<sup>2</sup>, and, in particular Article 1(5) thereof,

Having regard to Decision No 05bis/2010 of the Administrative Board of the Agency for the Cooperation of Energy Regulators of 21 September 2010 on the Delegation to the Chair of the powers to appoint new members of the Board of Regulators,

#### Whereas:

- (1) The Agreement on the European Economic Area incorporates Regulation (EC) No 713/2009 of the European Parliament and of the Council of 13 July 2009 establishing an Agency for the Cooperation of Energy Regulators, Regulation (EC) No 714/2009 of the European Parliament and of the Council of 13 July 2009 on conditions for access to the network for cross-border exchanges in electricity, and Regulation (EC) No 715/2009 of the European Parliament and of the Council of 13 July 2009 on conditions for access to the natural gas transmission networks.
- (2) In light of the above, pursuant to Decision of the EEA Joint Committee No 93/2017 of 5 May 2017, the national regulatory authorities of the EFTA States shall participate fully in the work of the European Union Agency for the Cooperation of Energy Regulators, and in all its preparatory bodies, including working groups, committees, task forces of the Agency and the Board of Regulators, without the right to vote.
- (3) On 6 May 2024, Orkustofnun, the National Regulatory Authority of Iceland, informed the Agency of its proposal to nominate Ms Hanna BJÖRG KONRÁÐSDÓTTIR as Member of the Board of Regulators, as replacement for Ms Halla HRUND LOGADÓTTIR and Ms Ninna ÝR SIGURDARDOTTIR, as Member of the Board of Regulators, as replacement for Ms Hanna BJÖRG KONRÁÐSDÓTTIR.

# Article 1

Ms Hanna BJÖRG KONRÁÐSDÓTTIR and Ms Ninna ÝR SIGURDARDOTTIR are appointed respectively as Member and Alternate of the Board of Regulators, in representation of Orkustofnun, the National Regulatory Authority of Iceland.

This Decision shall enter into force on the day of its adoption and shall be notified to the Board of Regulators, and Ms Hanna BJÖRG KONRÁÐSDÓTTIR and Ms Ninna ÝR SIGURDARDOTTIR.
